The Board is required to continue issuing 2022 new certifications or registrations until that time. If you are issued a 2022 certification or registration, you will still need to renew prior to January 1 to receive your 2023 certification or registration.

If you wish to submit your annual renewal fee along with your initial certification or registration fee(s), you can be issued a 2023 certification or registration so that you will not need to renew before the end of the year.
