Plumbers and Gas Fitters Examining Board 2015 Law Changes

- Provides for new/revised definitions to better fit Board operations
- Authorizes the Board to expend funds for public awareness
- Authorizes unbudgeted funds to be placed in a not-for-profit foundation to enable the funds to be expended for plumbing and gas education programs
- Eliminates bond requirement
- Exempts employees from the certification requirements while maintaining plumbing on or about the property of the employer
- Exempts from the certification requirements any person solely engaged in the testing of backflow prevention devices
- Requires the business name to be displayed on all construction and service vehicles engaging in plumbing and/or gas fitting for the general public
- Gives the Board the authority to discipline any certificate holder, registered legal entity, or person and places the process under the requirements of the Alabama Administrative Procedures Act
- Increases the violation for unlawful activity to a class A misdemeanor

5 Relating to the State of Alabama Plumbers and Gas
6 Fitters Examining Board and the practices and persons
7 regulated by the board; to amend Sections 34-37-1, 34-37-2,
8 34-37-4, 34-37-5, 34-37-6, 34-37-8, 34-37-9, 34-37-11,
9 34-37-12, 34-37-14, 34-37-15, and 34-37-17, Code of Alabama
10 1975; relating to defined terms, powers of the board to
11 advertise and promote the professions; board hearings; to
12 authorize the Alabama Home Builders Foundation; provide
13 further for prohibited activities and disciplinary powers of
14 the board; recognize registrations of the board; provide fees
15 for reciprocal agreements; provide for inactive status of
16 certified and registered individuals; provide further for
17 exempted activity; to repeal Sections 34-37-10 and 34-37-13,
18 Code of Alabama 1975, relating to temporary certificates and
19 bonding requirements; and to add Section 34-37-17.1, relating
20 to records of the board and confidentiality of records.

21 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

22 Section 1. Sections 34-37-1, 34-37-2, 34-37-4,
23 34-37-5, 34-37-6, 34-37-8, 34-37-9, 34-37-11, 34-37-12,
24 34-37-14, 34-37-15, and 34-37-17, Code of Alabama 1975, are
25 hereby amended to read as follows:

1 "§34-37-1.

2 "For purposes of this chapter, the following terms
3 shall have meanings respectively ascribed to them herein
4 unless the context clearly requires a different meaning:

5 "(1) APPRENTICE GAS FITTER OR PLUMBER. A person
6 other than a master or journeyman gas fitter or plumber, who
7 is engaged in learning and assisting in the installation of
8 gas pipe, equipment, apparatus, and appliances, and shall work
9 directly under the supervision of a journeyman or master gas
10 fitter or plumber, and who has successfully fulfilled the
11 registration requirements of the board and has been duly
12 registered by the board as such for the current year. The
13 apprentice shall have in his or her possession a current
14 annual certificate. The certificate shall be available for
15 inspection on request.

16 "(2) BOARD. The State of Alabama Plumbers and Gas
17 Fitters Examining Board as renamed by this chapter. The board
18 shall examine, certify, and regulate plumbers, gas fitters,
19 and medical gas piping fitters on a statewide basis pursuant
20 to this chapter.

21 "(3) CERTIFICATION. The process of testing at the
22 state level to determine the knowledge and skill of an
23 individual with respect to plumbing and gas fitting, and the
24 issuing of certificates to indicate that an individual has
25 passed the examination.

1 "(4) GAS FITTING, GAS SYSTEMS, or GAS WORK. The
2 installation, repair of pipes, fixtures, fittings, appliances,
3 or apparatus necessary for supplying natural gas for
4 residential or commercial use from the point of delivery and
5 all gas piping before connection to the combustion zone and
6 including the applicable venting of flue gases to the outside
7 atmosphere and the provisions for air for combustion and
8 ventilation, including all gas fitting work further defined by
9 any board rules and all codes currently adopted by the board.

10 This chapter shall not be construed to prevent any contractor
11 certified by the Alabama Board of Heating, ~~and~~ Air
12 Conditioning, and Refrigeration Contractors from installing,
13 replacing, or performing service or repair on natural gas
14 fired air heating/cooling appliances, excluding piping to them
15 provided the installing contractor has a valid certificate
16 issued by the Alabama Board of Heating, ~~and~~ Air Conditioning,
17 and Refrigeration Contractors.

18 "(5) JOURNEYMAN GAS FITTER. ~~A person~~ Every person
19 who engages in or works at the actual installation, repair, or
20 replacement of gas work, who has successfully fulfilled the
21 examination requirements of the board, has been issued a
22 journeyman gas fitter certificate by the board, and possesses
23 a valid and current annual certificate issued by the board.
24 The journeyman gas fitter shall have in his or her possession

1 a current annual certificate. The certificate shall be
2 available for inspection on request.

3 "(6) JOURNEYMAN PLUMBER. ~~A person~~ Any person who
4 engages in or works at the actual installation, repair, or
5 replacement of plumbing systems, who has successfully
6 fulfilled the examination requirements of the board, has been
7 issued a journeyman plumber certificate by the board, and
8 possesses a valid and current annual certificate issued by the
9 board. The journeyman plumber shall have in his or her
10 possession a current annual certificate. The certificate shall
11 be available for inspection on request.

12 "(7) MASTER GAS FITTER. ~~Any person engaged in or~~
13 ~~proposing to engage in the business of contracting to do, or~~
14 ~~of superintending the installation, maintenance, or repair of~~
15 ~~gas systems or gas work, either or both. The individual shall~~
16 ~~qualify to be a certified master gas fitter. If the business~~
17 ~~be a firm or corporation, at least one active employee of the~~
18 ~~firm or corporation shall be a duly registered and certified~~
19 ~~master gas fitter, actively and continuously connected with~~
20 ~~the conduct of the business. The master gas fitter shall have~~
21 ~~in his or her possession a current annual certificate issued~~
22 ~~by the board. The certificate shall be available for~~
23 ~~inspection on request.~~ Any person or legal entity that engages
24 in or works at the actual installation, repair, or replacement
25 of gas systems, that has successfully fulfilled the

1 examination requirements of the board, that has been issued a
2 master gas fitter certificate by the board, and that posses a
3 valid and current annual certificate issued by the board. The
4 master gas fitter shall have in his or her possession a
5 current annual certificate. The certificate shall be available
6 for inspection on request. This person may at any time
7 register with the board as principal for any business, firm,
8 or corporation.

9 " (8) MASTER PLUMBER. ~~Any person engaged in or~~
10 ~~proposing to engage in the business of contracting to do, or~~
11 ~~of superintending the installation, maintenance, or repair of~~
12 ~~plumbing, or both. The individual shall qualify to be a~~
13 ~~certified master plumber. If the business is a firm or~~
14 ~~corporation, at least one active employee of the firm or~~
15 ~~corporation shall be a duly registered and certified master~~
16 ~~plumber, actively, continuously connected with the conduct of~~
17 ~~the business. The master plumber shall have in his or her~~
18 ~~possession a current annual certificate issued by the board.~~
19 ~~The certificate shall be available for inspection on request.~~
20 Any person or legal entity that engages in or works at the
21 actual installation, repair, or replacement of plumbing
22 systems, that has successfully fulfilled the examination
23 requirements of the board, has been issued a master plumber
24 certificate by the board, and that possess a valid and current
25 annual certificate issued by the board. The master plumber

1 shall have in his or her possession a current annual
2 certificate. The certificate shall be available for inspection
3 on request. This person may at any time register with the
4 board as principal for any business, firm, or corporation.

5 "(9) MEDICAL GAS PIPING FITTER. A master plumber or
6 master gas fitter ~~whose certificate bears an endorsement who~~
7 holds a current certificate for installation of medical gas
8 piping. A journeyman plumber, ~~or~~ journeyman gas fitter,
9 apprentice plumber, or apprentice gas fitter who holds a
10 current certificate ~~whose certificate bears an endorsement~~ for
11 installation of medical gas piping shall be entitled to
12 install medical gas piping under the direction of a master
13 plumber or master gas fitter whose certificate entitles him or
14 her to install medical gas piping. An apprentice plumber or
15 apprentice gas fitter who holds a current certificate for
16 medical gas piping shall at all times be under the direct
17 supervision of either a master or journeyman who also holds a
18 current certificate. The medical gas piping fitter shall have
19 in his or her possession a current annual certificate ~~with~~
20 ~~endorsement~~ issued by the board. The certificate shall be
21 available for inspection on request.

22 "(10) MEDICAL GAS PIPING. Piping used solely to
23 transport gases used for medical purposes.

24 "(11) PLUMBING, PLUMBING SYSTEMS, or PLUMBING WORK.
25 ~~The~~ All work associated with the installation, repair, or

1 replacement of pipes, fixtures, or other apparatus necessary
2 either for supplying water or for removing liquid or
3 waterborne waste located on private property. The term is also
4 used to denote installed fixtures, backflow prevention
5 devices, drainage, vents, and water distribution systems
6 located on private property, and all plumbing work further
7 defined by board rules and all codes currently adopted by the
8 board, with the exception of work allowed by this chapter.

9 "(12) PERSON or PERSONS. Any individual, apprentice
10 plumber, apprentice gas fitter, corporation, professional
11 corporation, limited liability company, or other legal entity,
12 or any combination thereof.

13 "(13) PRINCIPAL. The individual responsible for the
14 contracting, superintending, installation, maintenance, or
15 repair of plumbing and/or gas fitting systems for any legal
16 entity, who is actively and continuously connected with the
17 conduct of the business, and is responsible to the board for
18 those responsibilities. The individual shall qualify to be a
19 certified master gas fitter or a certified master plumber, or
20 both. In addition, a principal must meet these requirements.

21 "a. At least one active employee of the legal entity
22 shall be a duly registered and certified master gas fitter or
23 plumber as defined in this section, actively and continuously
24 connected with the conduct of the business and registered with
25 the board as the principal of the business.

1 "b. The principal master gas fitter or master
2 plumber shall have in his or her possession a current annual
3 certificate issued by the board. The certificate shall be
4 available for the inspection on request.

5 "(14) REGISTRATION. The process of application with
6 the board with regard to apprentice plumbers, apprentice gas
7 fitters, all corporations, professional corporations, limited
8 liability companies and all other legal entities engaging in
9 the business of plumbing and/or gas fitting within the State
10 of Alabama.

11 "§34-37-2.

12 "(a) The Plumbers Examining Board as created by Act
13 No. 529 of the 1949 Regular Session of the Legislature (Acts
14 1949, p. 827), as amended, is renamed the State of Alabama
15 Plumbers and Gas Fitters Examining Board and the authority of
16 the board is expanded to allow the board to examine, certify,
17 and regulate plumbers, gas fitters, and medical gas piping
18 fitters on a statewide basis. The board may make and enforce
19 rules adopted in accordance with Chapter 22 of Title 41, the
20 Alabama Administrative Procedure Act.

21 "(b) The board is authorized to expend funds for
22 purposes of public awareness of the board and its rules and
23 regulations to include advertising, promotional materials,
24 event exhibiting, and other means approved by the board.

25 "§34-37-4.

1 "(a) The board shall meet when necessary for the
2 proper performance of its duties, but in no case less than
3 once a year. Meetings shall be held at places in the state as
4 the board deems necessary. At its first meeting next following
5 May 2, 1989, and every two years thereafter, the board shall
6 organize itself by electing from its membership a chair,
7 vice-chair, and a recording secretary. The board shall
8 appoint, employ, or contract with an executive director for
9 the board, and may appoint, employ, or contract with a deputy
10 director, neither of whom shall be subject to the state Merit
11 System. The executive director shall serve as treasurer of the
12 board, but the deputy director may serve as treasurer of the
13 board in the absence of the executive director or when
14 otherwise directed by the board. ~~In addition to any other~~
15 ~~duties, the deputy director may serve as a hearing officer for~~
16 ~~the board in any license proceeding pursuant to Section~~
17 ~~34-37-12.~~ The executive director and the deputy director shall
18 not be a member of the board and shall not be engaged or
19 otherwise connected with the plumbing or gas fitting industry.
20 The board shall set the compensation of the executive director
21 and the deputy director in accordance with regulations of the
22 State Personnel Board. Four members of the board shall
23 constitute a quorum for transacting business. Each member of
24 the board shall receive as compensation for services the sum
25 of two hundred dollars (\$200) per day for each day spent in

1 active service for the board. In addition to per diem
2 compensation, each board member shall be reimbursed for any
3 necessary expense incurred in performing duties as a board
4 member. The expenses allowable to each board member shall not
5 exceed the per diem amount of state travel expenses allowed by
6 law, from time to time, for state employees traveling on state
7 business. Employees of the board shall also be entitled to
8 reimbursement for traveling expenses incurred when traveling
9 on official board business at the rate for state employees
10 traveling on state business. The board may employ or contract
11 for stenographic or clerical help and compliance officers when
12 needed, and may purchase necessary office supplies, equipment,
13 and services.

14 "(b) The compensation and expense provided for in
15 this section, and all other authorized expenses, shall be
16 payable solely from fees collected by or on behalf of the
17 board. In no event shall any expense incurred by the board be
18 charged against any funds of the State of Alabama other than
19 the funds collected under this chapter.

20 "§34-37-5.

21 "(a) There is established a separate special revenue
22 trust fund in the State Treasury to be known as the State of
23 Alabama Plumbers and Gas Fitters Examining Board Fund. All
24 receipts collected by the board under this chapter shall be
25 deposited in this fund and used only to carry out this

1 chapter. The fund shall be disbursed only by warrant of the
2 state Comptroller upon the State Treasury upon itemized
3 vouchers approved by the executive director of the board or,
4 in the absence of the executive director, by the deputy
5 director. No funds shall be withdrawn or expended except as
6 budgeted and allotted according to Sections 41-4-80 to
7 41-4-96, inclusive, as amended, and only in amounts as
8 stipulated in the general appropriation bill or other
9 appropriation bills. ~~Any funds unspent and unencumbered at the~~
10 ~~end of each fiscal year that exceed 25 percent of the board's~~
11 ~~budget for the previous fiscal year shall be transferred to~~
12 ~~the State General Fund. All money remaining at the end of the~~
13 ~~fiscal year which exceeds 25 percent of the board's budget for~~
14 ~~the previous year shall be transferred to the 501(c)(3)~~
15 ~~nonprofit Alabama Home Builders Foundation to be used~~
16 ~~exclusively for classroom training tools at educational~~
17 ~~facilities that provide plumbing and gas fitting curriculums~~
18 ~~to include any program approved or accredited by the State of~~
19 ~~Alabama, the United States federal government, or the board.~~
20 ~~If at any time the Alabama Home Builders Foundation should~~
21 ~~lose its nonprofit status, those funds shall be transferred to~~
22 ~~the State General Fund.~~

23 " (b) The executive director and the deputy director
24 of the board shall, before entering upon the duties of their
25 office, make and file with the Secretary of State an official

1 bond in the sum of five thousand dollars (\$5,000), unless
2 covered by the state blanket bond. The appropriate premiums on
3 the bond shall be paid out of the funds of the board, and the
4 bond shall be executed by an approved bonding fidelity or
5 guaranty company qualified to do business in Alabama and
6 acceptable to the Secretary of State.

7 "§34-37-6.

8 "(a) It shall be unlawful for any person, ~~firm, or~~
9 ~~corporation to purchase a business license or to do or~~
10 ~~perform, or to contract, direct, or superintend any or other~~
11 legal entity to contract, engage in, offer to engage, or
12 convey the impression that he or she is certified in plumbing,
13 gas fitting, or medical gas piping within ~~any incorporated~~
14 ~~city or town or county of this state~~ the State of Alabama
15 unless the person has first registered or received a
16 certificate of competency, hereinafter referred to as
17 "certificate," that is in force and effect at the time the
18 plumbing, gas fitting, or medical gas piping is ~~done~~ offered,
19 performed, directed, or superintended, except as hereinafter
20 provided.

21 "(b) The board shall register all legal entities
22 engaging in, or offering to engage in, plumbing, gas fitting,
23 or medical gas piping in the State of Alabama upon forms
24 provided by the board, and upon the applicant first paying all
25 prescribed fees. Disciplinary action for the registered legal

1 entities may be the same as for certified individuals engaged
2 in plumbing, gas fitting, or medical gas piping.

3 "(c) The business name which is registered with the
4 board for each legal entity engaged in plumbing, gas fitting,
5 or medical gas piping shall be displayed in a prominent manner
6 on two sides of each service or construction vehicle. The
7 lettering shall be a minimum of two inches in height.

8 "~~(b)~~ (d) The board shall register every person who
9 may apply for an apprentice plumber or gas fitter registration
10 certificate upon forms provided by the board, upon the
11 applicant first paying all prescribed fees.

12 "~~(c)~~ (e) The board shall examine and pass upon the
13 qualification of every person who applies for a ~~journeyman's~~
14 journeyman plumber or gas fitter certificate upon forms
15 provided by the board.

16 "(1) An applicant for examination for a ~~journeyman's~~
17 journeyman plumber or gas fitter certificate shall submit
18 proof that the applicant has two years of current work
19 experience as an apprentice plumber or gas fitter or has
20 completed an apprentice training program approved by the
21 board.

22 "(2) Applicants for journeyman plumber or gas fitter
23 shall be examined, orally or in writing, upon the fundamentals
24 of plumbing or gas fitting, the theory and practice of
25 plumbing installation and construction or gas fitting work,

1 and the experience and ability of the applicant in practical
2 plumbing installation and construction or gas fitting work.

3 "(3) If the applicant is found to possess an
4 accurate knowledge of the theory and correct practice of
5 plumbing installation and construction or gas fitting work,
6 and sufficient experience and ability in plumbing installation
7 and construction or gas fitting work to safely and competently
8 apply that knowledge and practice, the board shall issue a
9 certificate, upon the applicant first paying all prescribed
10 fees.

11 "(4) The examination shall be administered by an
12 independent examining agency.

13 "~~(d)~~ (f) The board shall examine and pass upon the
14 qualifications of every person who applies for a ~~master's~~
15 master plumber or gas fitter certificate upon forms provided
16 by the board.

17 "(1) Applicants for examination for a master plumber
18 certificate shall submit proof to the board that the applicant
19 has at least one year of current work experience as a
20 journeyman plumber.

21 "(2) Applicants for examination for a master gas
22 ~~fitter's~~ fitter certificate shall submit proof to the board
23 that the applicant has at least one year of current work
24 experience as a journeyman gas fitter.

1 "(3) An applicant for a ~~master's~~ master certificate
2 shall be examined upon knowledge, training, and ability, in
3 the planning, laying out, and supervision of plumbing
4 installation and construction work or gas fitting work, and if
5 found to possess those qualifications, the applicant shall be
6 issued a ~~master's~~ master plumber or gas fitter certificate by
7 the board upon the applicant first paying all prescribed fees.

8 "(4) The examination shall be administered by an
9 independent examining agency.

10 "~~(e)~~ (g) No person shall be issued a certificate
11 without passing the prescribed examination. A person who has
12 passed the examination must become certified within 90
13 calendar days and shall not be required to take the
14 examination thereafter in order to secure a certificate in
15 subsequent years. An individual who passes the examination but
16 fails to become certified within 90 calendar days shall be
17 required to retake the examination. At least four examinations
18 per year shall be conducted, at a time and place prescribed by
19 the board after reasonable notice.

20 "~~(f)~~ (h) Any master plumber, master gas fitter,
21 journeyman plumber, ~~or~~ journeyman gas fitter, apprentice
22 plumber, or apprentice gas fitter performing medical gas
23 piping shall provide proof to the board that he or she has
24 successfully completed a current medical gas piping
25 certification program approved by the board. ~~The approval by~~

1 ~~the board shall be indicated by endorsement as a medical gas~~
2 ~~pipng fitter on his or her certificate. Any journeyman~~
3 ~~performing medical gas piping shall work under the direction~~

7 ~~shall be a United States citizen or, if not a citizen of the~~

11 "§34-37-8.

12 "(a) Any person who holds a certificate issued by
13 the board shall be issued statewide certification upon the
14 annual renewal of their existing certificate.

15 "(b) Any certificate issued by the board shall be
16 acceptable by any city, town, or county in the state and any
17 existing local statute or ordinance contrary to this section
18 is repealed, and no other competency certification or
19 examination shall be required of plumbers, gas fitters, or
20 medical gas piping fitters by any local governmental entity.

21 "(c) Any current registration or annual certificate
22 issued to any person individual by the board shall be in
23 possession of the person individual at any time he or she
24 engages in or proposes to engage as a master, journeyman, or
25 apprentice plumber, gas fitter, or medical gas piping fitter,

1 as the case may be, and upon request he or she shall make the
2 certificate or registration available for inspection and
3 identification by any person or persons for whom he or she
4 engages or proposes to engage as such, and for identification
5 by plumbing, gas, or other authorized enforcement personnel of
6 any governmental entity, board, or agency when requested.

7 "§34-37-9.

8 "The board shall set the necessary fees to
9 administer the requirements of this chapter and when adopted,
10 such fee schedule shall be in lieu of any fee schedule
11 heretofore prescribed by the board. The board shall not change
12 the fee schedule to be effective in the middle of a calendar
13 year.

14 "The certificates or registrations provided for
15 herein shall be issued by the board upon the payment of the
16 prescribed fees. All annual certificates or registrations
17 shall expire on December 31 of the year in which they are
18 issued. The certificate fees herein prescribed shall be in
19 addition to all privilege or license taxes otherwise levied.
20 Certificates or registrations renewed after December 31 shall
21 include the late renewal penalty established by the board.

22 "All applicants requesting replacement of lost or
23 stolen certificates shall be required to pay a ~~\$5~~ reissuance
24 fee based on the regular fee schedule.

1 "All ~~persons~~ individuals serving in the armed forces
2 will not be required to pay any back years for a renewal
3 certificate during the calendar year he or she is released
4 from active military duty.

5 "All other ~~persons~~ individuals shall pay back years
6 and prescribed penalties as set forth by rules of the board.
7 ~~unless proof satisfactory to the board is furnished indicating~~
8 ~~that the individual was not employed in such years in the~~
9 ~~plumbing or gas fitting trade.~~

10 "Any requests for waiver of back years and penalties
11 shall be reviewed and considered by the board. The board shall
12 vote to approve or disapprove each request.

13 "§34-37-11.

14 "The board may establish reciprocal agreements with
15 any other state licensing or certifying board which
16 recognizes, as a minimum, the standards prescribed by the
17 board, and may allow certified plumbers and gas fitters to
18 receive a ~~license~~ certificate in this state without taking
19 examinations if ~~such~~ the plumber or gas fitter is currently
20 licensed in the reciprocating state and upon the payment of
21 the prescribed fees.

22 "§34-37-12.

23 "The board may revoke or suspend any certificate or
24 registration if obtained through concealment, misstatement, or
25 misrepresentation of any material fact in the application for

1 such certificate. ~~, or for a willful~~ The board may discipline
2 any person as defined in Section 34-37-1 for a violation of
3 any law or ordinance pertaining to the business of the holder
4 ~~of such certificates.~~ and may impose fines, administrative
5 fees, or penalties not to exceed two thousand dollars \$2,000
6 for each violation. The board may also order restitution.
7 Before a certificate or registration may be suspended or
8 revoked, the holder thereof shall have notice in writing,
9 enumerating the charges against him or her, and be entitled to
10 a hearing by the board not sooner than five days from receipt
11 of notice. The holder of such certificate or registration
12 shall be given an opportunity to present testimony, oral or
13 written, and right of cross-examination and representation by
14 counsel. All testimony shall be given under oath. The board
15 shall have power to administer oaths, issue subpoenas, and
16 compel the attendance of witnesses.

17 "The decision of the board shall be based on the
18 evidence produced at the hearing and made a part of the record
19 thereof. The board may suspend any certificate or registration
20 up to one year or may revoke the certificate or registration.
21 The person whose certificate or registration has been revoked

12 business and the name under which such business is carried on,
13 and shall give ~~immediate~~ written notice within 30 days to the

2 existing piping installation or waste lines, provided such
3 plumbing work does not necessitate tying into waste or sewer

6 ~~utility company having fewer than 350 employees that is~~
7 ~~regulated by the Alabama Public Service Commission.~~

8 "~~(d)~~ (b) This chapter does not apply to any plumbing
9 work ~~done~~ performed by a property owner in or about a building
10 owned or occupied by him or her, or plumbing work ~~done~~
11 performed by anyone who is regularly employed by the property
12 owner to provide maintenance or other repair services if the
13 work is incidental to and in connection with the property for
14 which he or she is employed and engaged and is done on the
15 premises of the employer.

17 "(a) The board shall have the administrative
18 authority to discipline or require a certificate holder to
19 attend training specific to violations. The board has the
20 authority to levy civil fines or penalties to any registered
21 apprentice, certificate holder, or legal entity registered by

23 regulating plumbers, gas fitters, or medical gas pipe fitters

19 (b) The records of the board shall be evidence of
20 the proceedings of the board set forth therein, and a
21 transcript thereof, duly certified by the executive director
22 of the board under seal, shall be admissible in evidence with
23 the same force and effect as if the original were produced.

24 (c) Board records and papers of the following class
25 are of a confidential nature and not public record:

1 Examination material for examinations not yet given; exam
2 scores; letters of inquiry and reference concerning
3 applicants; board inquiry forms concerning applicants; pending
4 or closed complaints and investigative files which shall
5 remain confidential until an actual formal hearing may
6 commence; and all other materials of like confidential nature.

7 Section 3. All laws or parts of laws which conflict
8 with this act are repealed, and Sections 34-37-10 and
9 34-37-13, Code of Alabama 1975, are hereby specifically
10 repealed.

11 Section 4. The provisions of this act are severable.
12 If any part of this act is declared invalid or
13 unconstitutional, that declaration shall not affect the part
14 which remains.

15 Section 5. This act shall become effective on the
16 first day of the third month following its passage and
17 approval by the Governor, or its otherwise becoming law.
